Sub: Annual work plan to be executed by Service Providers under PGS-India programme every year - reg.

Sir / Madam.

As a follow up of decision taken in NEC meeting, a work plan has been proposed and intended to be executed by Service Providers/Facilitating Agencies on yearly basis in common for evaluation of their work being assigned as per details given below:

- 1. Every Service Provider should mobilize minimum 1000 number of farmers to take up organic farming and PGS-India certification in a year.
- Service Providers should organize 25 number of trainings. There should be minimum 25 number of participants in each training programme. The trainings should be organized for non-scheme farmers apart from project handling groups. The trainings conducted under project or any other scheme will not be considered for counting as 25 no. of trainings as said above.
- Service Providers should participate in atleast 5 no. of Organic Trade Fairs /Melas/Seminars, exhibitions (Including all) for promoting PGS products.
- 4. Service Providers should facilitate farmers to take up direct marketing and their no.'s should be recorded and communicated.
- 5. Service Providers should encourage farmers to take up branding, processing, packaging and labelling of PGS products.
- Service Providers should take up linkage of PGS certified farmers in Jaivik Kheti online web portal.
- 7. Service Providers should facilitate minimum 1,000 farmers per year to use PGS-India mobile app / Jaivik Kheti mobile app.
- 8. Service Providers should compile reports about data on farmers, success stories, videos of minimum 12 no. of farmers in a year.

It is requested to take up action as per the above work plan for the year. The extension / continuation of empanelment of SP/FA will be done on annual basis after evaluation of their above work performance.
